## **Conditions of Entry**

- 1. These Conditions of Entry must be read together with the Schedule. By entering, entrants accept these conditions.
- 2. Entry is open to South Australian residents who comply with the Entry Requirements. Entries submitted by Ineligible Entrants are not accepted. Persons 17 years and younger must first obtain consent of their parent or guardian.
- 3. The Competition will be run during the Competition Period in Item 5 of the Schedule.
- 4. To enter, entrants must follow the Entry Method as outlined in Item 7 of the Schedule, noting any Entry Requirements as outlined in Item 4 of the Schedule, and submit their entries during the Entry Period (Item 6 of the Schedule).
- 5. All valid entries will be entered into the Competition. Completed entries must be received during the Entry Period (Item 6 of the Schedule). Entries are deemed received at the time of receipt into Recitals Australia's database, not at the time of transmission.
- 6. The best valid entries as determined by the judges according to the Judging Criteria (Item 8 of the Schedule) will win the Prize described in the Schedule at Item 9. The Total Prize Pool is set out in Item 11 of the Schedule.
